**DEVELOPMENT OF E-GOVERNMENT IN ST LUCIA****Summary Report**

**1. PROJECT OBJECTIVES**

The main objective of the twinning project was to conduct an e-readiness assessment, in terms of strategy, human resources and backbone and hardware infrastructure in St Lucia and to train two St Lucia government officials in the use of Information and Communications Technologies (ICTs).

Other objectives included enhancing the ability of various government departments to efficiently interface among themselves, their employees, the public, and business with the latest ICT; promoting the use of Information and communications technologies (ICTs) among the public and business in St Lucia and Promoting the involvement of the citizens in the delivery of public service, and in the process enhancing transparency in government services.

**2. PROJECT DELIVERABLES**

- Between 11<sup>th</sup> and 30<sup>th</sup> January 2009, a Twinning Adviser engaged by the Malta Information Technology and Training Services Ltd (MITTS), namely Mr Alex Attard, visited St Lucia for 1 week to assess St Lucia in the area of e-government, with regard to backbone and hardware (servers, data centre) infrastructure as well as institutional aspects and suggesting a way forward on these matters.
- On 11 March 2009, Mr Alex Attard submitted a technical report on his findings, in consultation with the St Lucia Ministry of the Public Service, and after having considered the review of the report by Mr Joseph Tabone, Director of the Commonwealth Network of Information Technology for Development (Comnet-IT).
- Between 18<sup>th</sup> and 22<sup>nd</sup> May 2009, Mr Daune Louisy and Mr Marlon Narcisse - high ranking public officials from the St Lucia Government, as well as the Honourable Peter Lenard Montoute, Minister for Social Transformation and Human Services of St Lucia visited Malta to have a first hand experience as to how e-government is organised and delivered in Malta. They also followed a training programme organised by MITA
- The project was publicised in the National Press of Malta and St Lucia. On 28<sup>th</sup> May 2009 an advert was placed in the National Press of St Lucia, briefly describing the project. On 25<sup>th</sup> February 2009 an advert was placed in the National Press of Malta, briefly describing the project.
- The project was completed on 22<sup>nd</sup> June 2009 when the Technical Report was officially presented to Honourable Peter Lenard Montoute, Minister for Social Transformation, Public Service, Human Resource Development, Youth and Sports by Ms Juanita Thorington Powlett on behalf of the SSNED.
- The Final Administrative Report of the Project was submitted to the Network on 20 July 2009.
